Are you organizing a Digital Cleanup in your company?

Here's a memory aid:

Why am I organising a digital cleanup	<ul> <li>□ To become aware of the ecological impact of IT</li> <li>□ To take concrete action against my carbon emissions</li> <li>□ To raise awareness of my environment</li> <li>□ To extend the life of its IT equipment</li> </ul>
Digital CleanUp Data  What exactly are we going to clean up?	□ First, define the perimeter of the Digital CleanUp based on its relevance to you and your environment, feasibility, etc. Then you can choose to clean up the data from your:  □ Computer and cloud services □ Mailboxes □ Portable phones and tablets □ Social networks
Digital CleanUp Reusage  What exactly do we do?	<ul> <li>□ First, the perimeter of the Digital CleanUp should be defined based on its relevance to you and your surrounding environment, feasibility, etc. Then you can choose to act in one or more ways:         <ul> <li>○ Organize an awareness workshop (1 to 2 hours, onsite or remote) to understand why and how to regain control of one's smartphone</li> <li>○ Protect your smartphones and computers that still work,</li> <li>○ Reuse the equipment that still works en is collecting dust in your drawers</li> <li>○ Repair partially broken or malfunctioning equipment yourself, via a repair café or an authorized repairer,</li> <li>○ Donate your equipment that still works to an association that needs it or to acquaintances.</li> </ul> </li> </ul>
Digital CleanUp Recycling	<ul> <li>□ First, define the perimeter of the Digital CleanUp based on its relevance to you and your surrounding environment, feasibility, etc. Then you can collect all types of digital equipment:         <ul> <li>○ Fixed and portable computers</li> <li>○ Tablets</li> </ul> </li> </ul>









What exactly do we collect?	o Telephones
Who should we call on?	<ul> <li>Close and distant relatives</li> <li>Friends</li> <li>Group members through social networks</li> <li>Neighbors</li> <li>Members of our associations</li> </ul>
Digital CleanUp Data/Reuse  Where can we organize this?	<ul> <li>At your home or with friends         <ul> <li>Everyone together in front of the computer or on the phone</li> </ul> </li> <li>In a community center or club room</li> <li>Remotely via video conference, depending on the perimeter of the Digital CleanUp chosen</li> <li>By setting up a group through social networks</li> </ul>
Digital CleanUp Recycling Where can we organise this	<ul> <li>At your home or with friends         <ul> <li>Collect non-functional equipment (WEEE) together in a box</li> </ul> </li> <li>At a collection partner's house         <ul> <li>Take the equipment to an authorized collection point near you</li> </ul> </li> </ul>
When should the actions be taken?	<ul> <li>□ Before March 13         <ul> <li>○ Defining the perimeter of the Digital CleanUp (cell phone? Computer? Social networks?)</li> <li>○ Talking about it in your environment</li> </ul> </li> <li>□ During the week of March 13 to 18, 2023         <ul> <li>○ Giving the starting shot</li> <li>○ Prior to the operation, measure the volume of data and equipment according to the defined strategy</li> <li>○ Delete data within the chosen perimeter, at a common time (1 or 2 hours, for example) or at the discretion of each person</li> <li>○ Define actions for equipment reuse within the chosen perimeter</li> <li>○ Collection of equipment in according to the established perimeter</li> <li>○ Meet at the end of the time slot, or at the end of the day, to measure the data removed and the number of devices reused or collected.</li> </ul> </li> </ul>









	□ After March 18 □ Measure and communicate the impact to the Digital CleanUp Day project team, using the form and measurement document made available on the members' area of the website
Specifically, how do you proceed?	<ul> <li>Use the resources available         <ul> <li>The manuals (as inspiration or to make available to the participants) to carry out the cleaning according to the chosen perimeter and to measure the data before and after the Digital CleanUp.</li> <li>The manuals to give your digital equipment a second life and a decision tree to help you assess the type of equipment collected</li> <li>The sensitizing agents</li> <li>The official logo to be displayed on the various internal or external communication media related to the event.</li> </ul> </li> <li>Record your measurements on the form provided</li> <li>Go even further by drawing up a charter of good practices for the future and reviewing processes.</li> </ul>
